## **OPEN ENROLLMENT PERIOD**

During the Open Enrollment periodlovember 1 through November 30th, eligible employees may switch coverage from omeedical or dentablan to another, enroll in a plan for the first time, add or remove dependents; change membership from individual to family (or vice versa), with the transction effective January 1, 2024.
